

Annual summary 2017

NSLA is a collaboration between the ten national, state and territory libraries of Australia and New Zealand. We are committed to achieve more through working together. *Leading Collaboration*, our strategic plan for 2015-2017, outlines our priorities under two key strategies.

Strategy 1: Shared Solutions

Working together maximises efficiency, innovation and sustainability, and provides better outcomes for library users.

In 2017 NSLA:

- Undertook technical scoping and business requirements gathering for a collaborative approach to legal deposit of digital materials in Australia, with the 9 Australian NSLA libraries signing an agreement to begin the build of the National edeposit (NED) service.
- Delivered Data Unleashed, a professional learning program for 263 NSLA staff, focusing on data and its role in our libraries and work, complemented by Library Carpentry workshops to 142 staff in seven states and territories.
- Held a two-day event focused on day-to-day collection workflows in our libraries, featuring presentations, case studies and panel discussions presented by staff working in collecting and preserving digital materials.
- Created a directory to assist NSLA digital preservation staff with management of collections on 48 obsolete physical carriers.
- Piloted a 4-week Digital Preservation Internship at the National Library of New Zealand for three NSLA staff.
- Co-chaired GLAM Peak who were successful in receiving government funding for Stage 2 of the Digital Access
 to Collections project. The website was launched in February and delivery of regional workshops began in
 November.

Strategy 2: Communications and Influence

We will use our influence to remove barriers to collecting materials and providing access to information for the community.

In 2017 NSLA:

- Delivered the Right Wrongs digital production commemorating fifty years since the 1967 federal referendum on Indigenous citizenship, in partnership with the ABC and AIATSIS.
- Provided submissions to the Inquiry into NBN Rollout and the National Digital Economy Strategy consultation.
- Launched a toolkit to support a case study approach to calculating the cost of copyright compliance.
- Advocated for copyright reform, including participating in the Department of Communication's consultation on safe harbours and working with other peak bodies to promote the benefits of reform.
- Negotiated with SAI Global to secure an 18-month agreement to restore access to Australian Standards via NSLA libraries.
- Issued a strategy for dynamic collaboration between government and libraries to enable citizens to access and use increasingly online-only public services, and to fully engage in participatory democracy.
- Reported on the NSLA combined customer inquiry data for 2016-2017 and the Australian public library statistics 2015-2016.
- Supported seven communities of practice to share knowledge and insights in areas of strategic importance to NSLA libraries.
- Undertook a rigorous strategic planning process to review how our libraries work together and developed a business plan for 2018. The 2018-2020 Strategy begins from 1 January 2018.
